Discussion of plumbing work.

Basselman shared concerns with the well water and the impact of sediment in the water lines. There is also a sulfur smell and rust stains from the water. One plumber has provided information on installing an oxidizing system and a water softener to alleviate these issues. The Board requested multiple quotes for this work to both compare costs and professional recommendations on addressing the issues. Quotes will be requested from no less than two more plumbers and shared at the next meeting.

Discussion of parking lot paving project.

Basselman asked the Board when they thought it was necessary to repave the parking lot. This would likely involve removing several inches of blacktop to redo the work vs. recoating. Basselman spoke to Denny Bell, owner of the two properties next to WCBDD, about thoughts on redoing his portion of the parking lot. Denny expressed that he does not plan to do anything this year, but is responsible for costs on the north side of the driveway approach and would reimburse the Board for costs incurred for any work done. The Board agreed that potholes could be repaired this year, and reassess the need to completely redo the parking lot in 2022.
